Registration for the Capitolina nursery School
Year 2022/ 2023
Registrations are open
from 4th January to 28^h January 2022

1. REQUIREMENTS FOR REGISTRATION

1.1. Age

All children can be registered on 31st December 2022 at the age of three or they have not completed, on the same date, the sixth year of age, in compliance with the mandatory vaccinations established by the Law n.119 of 31st July 2017.

It is also foreseen the registration of the children both male and female that will be three years of age on 31st January 2022. In this case their admission is subject to the exhaustion of the municipal waiting list of the children who have completed 3 years by 31st January 2023, as well as the exhaustion of the ranking for applications submitted after the deadline (28th January 2022) which will be three years before 31st December 2022.

For request of families, both male and female can be enrolled at the Capitoline nursery School who will be three years of age by 30th April, 2023, born in the months of February, March, and April 2020, so-called "anticipators".

In order to guarantee pedagogical quality, flexibility and specific educational offer in line with the particular age group concerned, the admission of the children both male and female at their early attendance is subject to the following conditions:

- a) availability of places;
- b) verification of the exhaustion of any municipal waiting list and of the list of children who have submitted their application after deadline, also for the children who will be three years of age by 31st January 2022;
- c) availability of suitable premises and equipment from the point of view of practicability and functionality, such as to meet the different needs of children under three years of age, who were born in February, March and April 2020;
- d) pedagogical and didactic evaluation, by the college of the teachers, will be based on time and methods of reception.

1.2. Residence

The parents can apply for registration of their children both boys and girls resident in Rome capital by one parent or tutor the form can be submitted by the parents of the children who are resident in the territory of Rome Capital with at least one parent, guardian or custodian resident in the municipality where the chosen school is located, or in one of the municipalities where the grandparents of the children are resident, or rather the employment of one of the two parents. The family unit can be composed of both parents, a single parent, a guardian or custodian.

Registration applications are accepted with reserve:



- the children of the same family are awaiting residence (coming from other Municipalities);
- of the children whose families are awaiting transfer of residence both in their own Town and from another Municipality.

In both cases the family must present self-certificate, pursuant to Presidential Decree 445/2000, the transfer of residence in progress. The children will be included in the rankings. By 31st August, 2022, the Municipal Childhood Management Office will verify, under penalty of forfeiture, that the new residence is effective. All children present temporarily can be registered in the territory of Rome Capital, even if they do not have residence in relation to current international, national and regulatory standards; for those children, the Administration ensures, also through network agreements and inter-relationships between areas, for best integration.

2) HOW THE SCHOOL FUNCTIONS

The Capitoline Nursery School is free.

The service of each single nursery school is divided into sections that are usually composed of 25 children. Without prejudice to the inclusion of the child in his or her class group, in the nursery school specific laboratory activities are carried out, including interclass activities.

2.1. Calendar

The Nursery School follows the school calendar approved by the Lazio Region, which obligatorily provides for the opening on the 15th September every year, automatically extended to the following day if it falls on a Saturday or Sunday, and the closing on 30th June of each year.

2.2. Timetable

The school timetable, where both full-time sections and morning sections are active:

- **morning sections: Monday to Friday from 8.00 am to 1.20 pm with exit starting from the previous half hour;**
- **full-time sections: Monday to Friday from 8.00 am to 5.00 pm, leaving at 4.00 pm. The family can indicate a further option with exit from 14.00pm -14.30pm. The full time shift the children eat (see 4.1).**

The choice of the morning or full time schedule is binding for the entire school year.

For the following school year 2022/2023, users interested in changing the time slot with changeover from morning to full time and vice versa, will have to submit a new application form, as part of the new public notice.

2.3. Teaching of the Catholic religion

When completing the registration application form, the family can choose the teaching of Catholic religion or not. The school will provide alternative activities for children whose parents had chosen not to use this teaching.

This choice is binding for the entire school year.

2.4. Time and method of insertion

Entry into the nursery school represents a particularly delicate moment for the children male and female in their growing stage, as it may constitute for many the first meeting with a wider community.

The school promotes the reception of the children organizing spaces and time of reception and acclimatization, through collective and individual meetings with the parents, planned before the starting of the school and also provide time for the children, and gradual personalized.



For newly enrolled girls and boys, there will be a staggered and personalized insertion, which will be carried out continuously during the first week opening of the school. In compliance with the rhythms and needs of each child, the acclimatization period must be concluded for them by September.

3) INCLUSION

Inclusion involves all the children and guarantees participation in the educational and school life in order to achieve the maximum possible in terms of learning and socialization through personalized paths of growth and education.

An inclusive nursery School educates the value of diversity as an exchange that enriches and overcomes preconceptions. We are included in a context where we experience common experiences that favor the sharing of objectives and strategies and develop a sense of belonging to the group. This process is the fruit of the collegial initiative, is carried out in harmony with the whole educating community and is not guaranteed exclusively by the individual teacher or operator.

The Administration of Rome Capital is committed to implement and guarantee the full participation in the normal school life of all the children, regardless of their personal and social conditions, valuing the rights of each person, implementing the constitutional principles.

It ensures, also through network agreements and interrelations between areas, the best integration of boys and girls of different nationality and Italian citizenship.

3.1. Boys and Girls with disabilities

The Administration of Rome Capital protects the rights to care, education and health of the children with special educational needs, in compliance with constitutional principles and current legislation (L.104/92).

In particular, for children with disabilities, the nursery schools of Rome Capital outline, based on an interactive and organizational pedagogical model, inclusive teaching and an individualized educational project shared with parents, ASLs or Accredited Centers, which follow the children. The project is aimed at the well-being and individual and collective growth, is aimed at achieving, with respect to the possibilities of each, high levels of learning, sociability, identity, autonomy and to guarantee a harmonious development of the person within a coherent life project promoted in collaboration with families.

The disability must be recognized with point a report or provisional certificate of the forensic medical commission (Law 104/92), or with certification issued by public health facilities (ASL or Hospital).

For the purposes of awarding the score, this documentation must be attached to the application for registration or presented to the municipal office of competence, by 25th February 2022, in view of the publication for the provisional ranking established for 2nd March 2022.

Subject to the availability of places, children with disabilities may be admitted at any time of the year.

3.2. Assignment of personnel for school integration

In relation to the regulations in force, for the assignment of staff for school integration, families must present, together with the application form, the following valid certification:

- Statement of ascertainment of the forensic medical commission of the ASL L.104/92; the recognition of Law 104/92 establishes a term of validity of the disability within which it must possibly be renewed;
- Certification for school integration issued by the TSMREE service of the ASL of residence of the child. The aforementioned certification must include the clinical diagnosis and indicate the necessary professional resources (Support teacher, Educational Autonomy Operator, Assistant Specialist for sensory disability), as well as specifying the updating times for the same;



- Functional diagnosis prepared by the TSMREE service of the ASL or by the rehabilitation center recognized by the Regional Health System, by the specialist center, university teaching hospital and research institutes.
- The request for personnel integration, signed by the parents.

In Rome Capital nursery schools, the continuity and stability of the educational path is guaranteed by the teachers in charge of the section and not by the teachers with part time.

It is the duty of the Teaching Committee to engage in the process of inclusion and implementation of the Individualized Educational Plan for the disabled, sharing with any new additional figures to sustain their teaching.

The additional integration teachers are assigned by the Administration to support the whole service for the presence of children with disabilities, with the aim of guaranteeing the educational co-responsibility of the teachers present in the reference section. The support teacher is employed in support of the Teaching Committee due to the presence of the user with a disability and not assigned exclusively to the individual child. (D.G.C. 697/2003).

If in the chosen school there is a presence of children with disabilities that does not guarantee an effective educational experience to all the children, the municipal offices will agree with the families the choice of an alternative school with respect to the option initially formulated, also taking into account the actual distribution of access applications on the municipal territory.

The family with disabled children must apply with sanitary request for school support or assistance in autonomy should be presented at the municipal invalidity for academic year.

In case a child should stay more than 6th years the parents should confirmed the registration with sanitary documents about the child.

4) SUPPORT SERVICES

4.1. School catering

Full-time subscribers, after the formal acceptance of the place, must pay a fee to participate in the expenditure for the use of the school catering service. This fee is payable in full regardless of the actual attendance of the child and must be paid for 10 months from September to June of each school academic year, as required by the Deliberation of the Capitoline Assembly n. 117/2018.

The request for a reduced rate for the catering service, for the school year 2022-2023, must be submitted through the specific web application of the Institutional Portal of Rome, accessible by following the path Services - School - School catering and special diets - Application Discounted School Catering Rate from 1 March until 30 September 2022 (Capitoline Assembly Resolution n.117 of 23 October 2018), or directly at the following link https://www.comune.roma.it/web/it/scheda-servizi.page?contentId=INF83094&stem=school_mens. The subsidized fee is calculated based on the value of the Equivalent Economic Situation Indicator (ISEE) reported in the Single Substitute Declaration (DSU). Beyond the deadline of 30 September 2022, the maximum contribution amount of € 80.00 per month will be applied.

Parents interested in promptly initiating the procedure for issuing an ISEE certificate from INPS are invited, including through the CAF, given the time required for the delivery of the document. It will be the responsibility of the applicant to monitor, in the reserved area of the Rome Capital institutional portal, the processing status of the reduced rate request to verify the acceptance of the request by the Administration. Otherwise a communication will be displayed in which the reason for the rejection will be indicated, pursuant to art. 3 of Law 241/90.

The applicant may ask the competent Municipality for the provision of special diets for health or religious ethical reasons or a "light" diet, upon presentation of a certificate prepared by the doctor according to the



indications contained in Model 1 and Model 2, which can be downloaded in the section Forms at the following link

The aforementioned documentation must be delivered to the Dietitian Office of the territorially competent Municipalities, in order to provide for the development of adequate menus, before the start of school activity.

5) APPLICATION FORM

5.1.When and how to present the application

The application form for registration must be submitted exclusively on-line **from 4th January to 28th January 2022**, through Rome Capital portal (www.comune.roma.it) following the path:

Services - School - nursery School - Online Services - Registrations and Rankings Childhood Capitoline

Schools all the requisite must be presented before the expiring date

Applications for enrollment that arrive first have no right of way in formulating the ranking list for access to the service.

In the event of a tie, priority will be given to the child born before.

In case of further parity, the information system will proceed to random extraction.

At the time of booking the request for access must be specified.

5.2.Selection of the school

In the application form, the family must indicate the particular school they wish to enroll the child by consulting the appropriate list published on the Rome Capital portal (www.comune.roma.it) following the path:

Services – School - Nursery School-Capitoline Nursery Schools

Only **one application** form is allowed with the indication of only **one school**, within the Municipality:

- residence of the family of the child
- the workplace of one of the parents (including the parent with whom the child does not reside)
- residence of the parent with whom the child does not reside
- residence of grandparents
- of the place where the residence of the family unit is to be transferred
- adjacent to that of residence of the family unit or of one of the parents or guardian / custodian.

The Capitoline Administration favour the choice of the school closest to the residence, to ensure integration with the social environment of the children. For this purpose, the Municipalities define the division of the territory into "catchment areas". Where a school is chosen, which is located in the catchment area where the applicant consult the website of Rome capital, the family unit resides (or one of the foster parents or guardian), or where it is intended to transfer the residence of the same, an additional score equal to 5 will be assigned to the application.

The list of places available and sections for enrollment in the nursery school is announced by each municipality through the report attached to this Public Notice.



In the event that the school closest to the residence does not have enough places available compared to the request, the Municipality has the right to assign the aforementioned 5 points for the school located in the neighboring basin, also belonging to another Municipality, as specified in the report attached to the Public Notice.

6. ADMISSION RANKINGS AND WAITING LISTS

6.1. The rankings

On the basis of the applications received and eligible, the Municipalities proceed with the attribution of the overall score for each child, according to the table "criteria and scores" contained in the appendix to this Public Notice..

Based on this score, the chosen time, of the option expressed and the places available, the relevant Directorates of the Municipalities formulate the **temporary rankings** for each school, indicating the relative admissions and waiting lists. These rankings will be published **by 2 March 2022** in the relative schools, in the municipal offices and can be consulted online in your reserved area.

Should the family find **errors of assessment**, it may appeal to the Director of Socio-Educational Direction of the Municipality territorially competent with respect to the school for which an application was filed, within 10 working days from the date of publication of the aforementioned ranking.

The Director of Social and Educational Direction will have to reply within the next 10 days.

Any errors or omission on the part of the applicant cannot be remedied during the appeal.

The final rankings, approved by the Director of Socio-Educational Direction, after examining the appeals, will also be published online in the above-mentioned offices before **31st March, 2022**.

The families of the children presented the following with registration for the service:

- to check their placement in a definitive ranking on time;
- to accept, in the event of admission, exclusively online mode, the seat offered **by 20th April 2022, under penalty of forfeiture**.
- to communicate to the Municipality of belonging, at the time of acceptance of the place, the presence of any food allergies and / or intolerances documented with a medical certificate, in order to provide adequate menus.

To the twin children male and female a specific score is attributed. In the event that the assigned score and / or Availability of place allows the inclusion of only one of the twins, the family has the right not to let the admitted child attend without losing the right acquired, pending the possible scrolling of the ranking for the insertion of the twin sister or twin brother.

6.2. Waiting list

With regard to children not admitted following the classification procedure referred to in point 6.1., the Administration will put in place the following actions:

- the children who are not admitted are included in the waiting list of the chosen school on the basis of the score obtained and the choice of full-time and morning section, to which will be proposed poses made available at the school after the phase of registration: in this case, if the offered seat is not accepted, the application is considered lapsed;
- posters available at schools without a waiting list will be offered to users included in the waiting lists of schools belonging to the same school or neighbour area, taking into account their position in the ranking list and the time chosen;
- after these operations, each Municipality will proceed with the unification of the waiting lists of all the schools in the territory to propose admission to the places that have become available exclusively based on the position of the child in the single ranking.



In all these cases, the seat offered with appropriate notice from the Municipality must be formally accepted within two working days from the date of the communication. In addition, those who have chosen full-time must present the Single Substitute Declaration (DSU) or ISEE certificate to quantify the rate for the school catering service within 15 days after acceptance of the place. Failure to submit the necessary documentation will result in the application of the maximum rate.

Additional admission can be made up to the maximum term of **31st January, 2023**.

The children with disability can be admitted to attendance with priority in any period of the school year without prejudice to the availability of places. This category also includes children reported by social services upon presentation of appropriate documentation.

They can be equally admitted at any time of the year, without prejudice to the availability of places, even if with a lower priority than the children with disability and reported by social services, also those children, in possession of a certificate of frequency, even if relative to a few days, coming from other Municipalities, or from other cities, following transfers due to registry changes in the family nucleus, except in cases where the failure to start schooling is due to the Local Entity own by the school service.

7. DECATS – ABSENCES - RENUNCIATION OF SERVICE

1. The non-formal acceptance of the post to be made online on **20th April 2022** is considered a reason for forfeiture.
2. Furthermore, the non-fulfillment of the obligations envisaged by law 119 of 31st July 2017 on the subject of vaccination prevention is considered a reason for forfeiture.
3. The child will be considered as having renounced the service, with the consequent forfeiture of the place, the child who **has never attended 10 days** after the opening of the school and, for this absence, no formal justifications have been provided.
4. Those who are admitted during the year and who have not attended for 10 consecutive days starting from the date of admission set by the Municipality and who have not been given formal justifications for this absence will be considered as withdrawn.

The indication of DM n.80 of 3/08/2020 confirmed in the school program approved with DM n. 257 of 06/08/2021, absence because of illness after three days without counting feast days for the child to come back to school must bring or present a medical certificate that he/she is healthy from the pediatrician or family doctor.

Absence because of illness the family of the child must communicate the school for the child to come back to the school.

In case the child is affected by virus SARS-COV-2 for the child to enter in the school the family must present all the necessary medical certificate by the order 65/2020 and DGR 17 November 2020 n.852.

Absences during the year exceeding 30 consecutive days that are not justified with a medical certificate or with a declaration by the parent, showing proven reasons, automatically entail the loss of the post

It is specified that the reconfirmation from one school year to the other is automatic for all those enrolled who are of age to attend the childhood service. Citizens who do not intend to reconfirm the position of a child to kindergarten, they can renounce the service through the online functionality provided.

Children with age not consistent with the school cycle are excluded from automatic reconfirmation

8. Notice on the completion of the application form

The applicants must pay particular attention in feeling the registration form online they must have enough time to clear any doubt or any problem before the expiring date.



Particular attention must be paid when completing the application form, indicating all the data requested, in the absence of which the request will be considered inadmissible, also attaching all the documentation useful for the attribution of the scores, the Municipality has the right to report any deficiencies in the documentation in compliance with current legislation; in case, any changes or additions to the applications already submitted must be made by 28th January 2022, subject to the health disability certification referred to in point 3.1.

The competent municipal offices, listed in the attached list, are available according to the respective opening times to the public, as indicated on the web pages, to provide any clarifications on the presentation of the request, as well as to ensure the necessary support for sending online of the same.

When filling in the application form it is noted that the fields marked with the character * are mandatory and that it is necessary to tick all the fields of interest for the recognition of the correct score, any errors or omissions, cannot be remedied during the appeal.

It is represented that any decision regarding the compilation of the application must be made in compliance with the provisions on **parental responsibility** pursuant to articles 316, 337 ter and 337 quater of the Civil Code, which require the consent of both parents.

Users are informed that the data of the children attending and enrolling will be transmitted to the Lazio Region for the verification, through the **Vaccinal Register**, of the obligations provided for by Law 119/2017 and for the girls / boys not in compliance with the prescribed vaccination obligations, the refusal of access to the service and finally the forfeiture of registration is foreseen as a precaution.

In this regard, it should be noted that, since when completing the application, the certification of vaccination regularity is required, in the event of false declarations, pursuant to and for the purposes of Articles 75 and 76 of the Presidential Decree 445/2000, the sanctions of art. 483 of the Criminal Code "Ideological falsehood committed by the private in a public act", as well as the forfeiture of the benefit obtained. To this end, the competent municipal offices reserve the right, as required by law, to carry out checks aimed at ascertaining the information provided.

Users are informed that the data of attending children will be transmitted to the Lazio Region for compliance with Law L. 119/2017 concerning the Vaccine Registry; provision for reject of school services at the end of registration.

The parents are pursuant to the General Regulations for Protection of Personal Data (RPGD) - (EU) 20161679, Articles 13 and 14, the data provided are prescribed by the provisions in force and acquired for the institutional purposes provided by the law for the sole purpose of the administrative procedure for which they are requested, and will be used exclusively for this purpose.

At the end of the registration the system will release receipt.
